2. Ordinary Membership

Ordinary (Life) membership

- Criteria • 21 years and above
- Singaporean/Permanent Resident

Ordinary (Annual) membership

- Criteria • 21 years and above
- Singaporean/Permanent Resident
 - Employment/ Dependent Pass Holder*/ Full Time Student Pass Holders*

Ordinary (Youth) membership

- Criteria • Below 21 years old
- Singaporean/Permanent Resident
 - Employment/ Dependent Pass Holder*/ Full Time Student Pass Holders*

3. Associate Membership

Criteria • 21 years and above

- Singaporean/Permanent Resident
- Employment/ Dependent Pass Holder*/ Full Time Student Pass Holders*
- Able to enjoy the privileges of participating in all courses and programmes except the use of facilities unless otherwise stated.
- Membership is only valid for 1 year. No renewal.

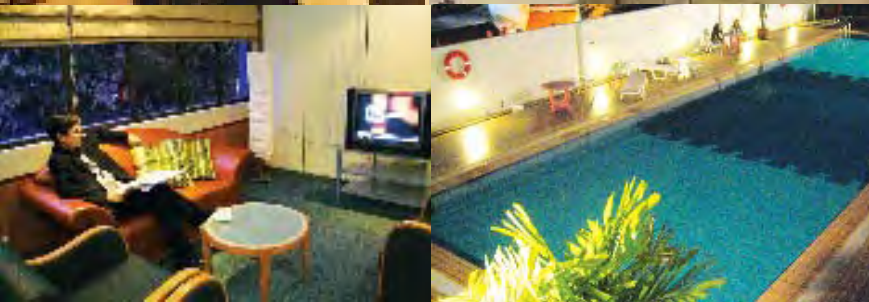
4. Associate Youth Membership

Criteria • Below 21 years old

- Singaporean/Permanent Resident
- Employment/ Dependent Pass Holder*/ Full Time Student Pass Holders*
- Able to enjoy the privileges of participating in all courses and programmes except the use of facilities unless otherwise stated.
- Membership is only valid for 1 year. No renewal.

* All passes must have at least 6 months of validity (before the expiry date) at the time of application.

FREQUENTLY ASKED QUESTIONS

1. Can I bring my family and/or friends to the YMCA? If so, can they use the facilities?

Yes, members are allowed to bring a maximum of 3 guests to the Association at any one time (relevant guest charges apply) and they will have to be signed in to use the facilities.

2. How will members be informed of the latest membership benefits and activities?

Members will be informed via eNews, Y Factor and notices put up around our premises.

3. What should I do if I lose or damage my membership card?

You would need to obtain a lost/damaged card replacement at the Members' Service Counter of YMCA. For damaged card replacement, members have to produce the damaged card upon their request of replacement.

Replacement card charges are as follow:

Lost Card: S\$10.00 (excluding GST)

Damaged Card: S\$5.00 (excluding GST)

4. I want to terminate my membership. What shall I do?

To terminate your membership, you will have to fax in to Member Services Centre at 6336 8003, indicating your Name and Membership ID, to effect your termination. All outstanding dues will have to be settled. However, there will not be any refund of any membership and/or course fee paid prior to the termination.

5. Is my YMCA membership card transferable?

No. Your YMCA membership card is strictly non-transferable and must be produced at the premises facilities. Actions will be taken against any member found transferring or misusing the card. In such instance, the card will be confiscated.

TERMS AND CONDITIONS

1. The Association reserves the right to accept or reject a membership application without assigning any reasons whatsoever.
2. The Association is not obliged to respond to any request from an unsuccessful applicant.
3. The YMCA membership card is non-transferable. Fees paid for successful applications are non-refundable.
4. Upon termination, no fee is refunded (on pro-rata basis).
5. Release of information relating to you.
We may, in the following circumstances and for the following purposes, at any time and without liability to you, whether or not you continue to use the Card, disclose any information relating to you or your Cards to any third party as we may deem fit and at our absolute discretion.
 - For the due administration of the Y Card
 - For the purpose of achieving any of the YMCA objectives
 - When required to do so by law or by lawful authority
6. Members must notify us promptly of any change in your personal particulars.
7. Members must carry their membership cards at all times. Members are only allowed to sign in a maximum of 3 guests at a guest entrance fee of \$1.05 per guest (inclusive of GST). In addition, guests must pay applicable facilities usage fees. All payments must first be made at Member Services Centre on Level 1.
8. Gambling, smoking and consumption of alcoholic beverages within the premises are strictly prohibited.
9. The Association reserves the right to revoke membership, refuse entry or ask any member to leave YMCA premises for:
 - failure to pay membership and/or course fees
 - violating the rules and regulations of YMCA
 - damaging the property of YMCA
 - causing disturbance to other members
 - exhibiting any other behaviour deemed unbecoming of a member.
